Introduction

Background

Healthwatch Isle of Wight is the only 'consumer champion' for people using local health and social care services, with statutory powers. As an independent statutory body, we have the power to make sure NHS leaders and other decision makers listen to people's feedback and improve standards of care.

Over the last 12 months, we have received feedback from unpaid carers, about their experiences with healthcare services, their own mental and physical health and the challenges their caring responsibilities presents.

In putting together this toolkit, we worked closely with Carers IW and local GP surgeries to listen to the views of unpaid carers, GPs and Patient Participation Groups.

An Island Look

An cnpaid Carer is defined by the NHS as: "A carer is anyone, including children and adults who looks after a family member, partner or friend who needs help because of their illness, frailty, disability, a mental health problem or an addiction and cannot cope without their support. The care they give is unpaid." ¹

Many carers don't see themselves as such, as they believe that caring for family or friends 'doesn't count', or that it doesn't take up much time.

According to the 2021 census, there are over 19,000 carers on the Isle of Wight.


Unpaid carers can come in any form and can be of any age – it is estimated that the Isle of Wight currently has around 300 young carers (those aged 18 and under). 2

Caring responsibilities can have an adverse effect on health, both physical and mental. These risks are increased with the level of the

care that person gives. This can lead to the carer themselves becoming ill, or unable to continue their caring responsibilities and lead to the cared for person being admitted to hospital or residential care.

Nationally, unpaid carers have been estimated to have a value of £530 million per day. ³ It is not unreasonable, therefore, to state that unpaid carers are invaluable and that there is a great need to provide them with support when needed. The NHS put together a 'Commitment to Carers' ⁴, describing them as 'vital'.


On the Isle of Wight, the Isle of Wight Council, together with Isle of Wight Integrated Care System and Isle of Wight NHS Trust have created a new Carers Strategy (2023-2028), which lists their number 1 priority as 'Ensuring all island unpaid carers are recognised.' ²



A GP Perspective

The NHS states that 'Primary Care has a unique opportunity to make a telling contribution to improving the lives of Carers." $^{\rm 5}$

GP surgeries are often the 'front line' when it comes to caring and, as such, are well placed to help, support and signpost where appropriate. NHS England/ NHS Improvements have identified 6 quality markers that General Practice should focus on regarding the identification and support of unpaid carers. ⁶



This is a focus on a holistic approach to support for unpaid carers, which goes beyond medical intervention.

It provides help, signposting and support. More than this, it highlights the importance and value the NHS places on unpaid Carers.

Unpaid Carers are encouraged to register with their GPs in order to take advantage of this. The aim of people registering is to enable the surgery to take their specific needs into account and provide allowances where necessary.

There are multiple benefits of registering with a GP as an unpaid carer, not least because the surgery will be able to provide 'double appointments' so that both the carer and the person they care for can be seen at the same time. It also provides the GP with an insight into the carer's needs and enables them to support them better, by providing annual health checks and flu vaccinations, discussion about mental health and support with benefits and prescriptions.

Feedback

We met with unpaid carers groups, contacted GP surgeries on the Isle of Wight and discussed the topic with various Patient Participation Groups. For the most parts, there were similar themes that ran through all groups.

Practice Managers told us that when registering new patients, people are asked if they have caring responsibilities, and if so, they are 'coded' on their system as an unpaid carer, and that is flagged up when interacting with them. There is a form for the patient to complete if they would like to register as a carer at a later date, as exampled below:

It was recognised that during the Covid pandemic, more people registered as unpaid carers, as they were priority for vaccinations.

It was also mentioned that surgeries found it difficult to identify when people stopped being unpaid carers but they understood that this was a sensitive topic.

A few surgeries detailed 'opportunistic' registration of carers, and others felt that there was more that they could do in order to promote the importance of this.

Feedback gathered from Patient Participation Groups⁷ highlighted the biggest barrier stopping people from registering as an unpaid carer: 'What is an unpaid carer?' Many did not understand that caring responsibilities for family and friends still counted. In particular, caring for parents or spouses was 'just something they did', and they didn't identify themselves as being a carer.

Many weren't aware of benefits or the opportunities of registering with their GP as an unpaid carer, but could see how this would be helpful.

In conclusion, when looking at a Comms Toolkit for GP Practices, the focus should be on 2 distinct areas:

1: Helping carers identify themselves as an unpaid carer.

2: Highlighting the ease and benefits of registering as a carer with the surgery.


