To include treatment and appointment schedules, admissions and discharge, and processes for service change. This to be a model for other specialities with regard to cross-Solent travel.	The Isle of Wight Council is keen to be consulted in this process. The development of a local NHS charter provides the opportunity for greater transparency of the existing support offers available in relation to cross-Solent travel and will help to ensure that the people of the Isle of Wight are aware of the options available to them. ASC are already active participants in the Patient Travel Improvement task and finish group and will continue to be so. Whilst it is not within the gift of the Isle of Wight Council to influence treatment and appointment schedules, admissions and discharge, and processes for service change, we will work closely with our colleagues in the integrated Commissioning Team to provide advice and assistance in the development of options to address these areas. 5. Local agencies should no longer take decisions in isolation about financial assistance to people travelling for cancer treatment. Before any proposed change, partners including the local NHS, local authority and voluntary and community sector should jointly explore all options to maintain and improve travel support.	The Isle of Wight Council is reviewing the provision of funding which supports the current NHS Trust discretionary cross Solent travel scheme. The IW Council currently funds cross Solent travel for patients receiving Radiotherapy, Chemotherapy or Renal Dialysis and provision of this support makes us nationally unique. Local authorities have no duty or responsibility to fund transport for NHS patients. Indeed, that is why there is a national scheme, the Healthcare Travel Cost Scheme (Travel Expenses and Remission of Charges) Regulations 2003 (HTCS), which is means tested and provides statutory funding to people on low income or specific qualifying benefits. 	The Council has provided additional funding of £60,000 per year to enable people who do not qualify under the statutory scheme to receive financial support with their travel costs as in 2005 the NHS Trust withdrew their funding in this regard. The support currently provided by the IW Council is not means tested.	
	Provision of this funding is not a statutory obligation of the Isle of Wight Council and therefore we will be undertaking a public consultation to inform decisions about any future funding provision. The Council will be working with an independent organisation to develop and undertake this consultation.	
	The role of ASC within the Patient Travel Improvement task and finish group will enable the opportunity for wider discussion about both the consultation and the information that consultation provides.	
	Any decision in relation to ongoing financial support for cross-Solent travel will be informed by the public consultation with a final decision being taken by Cabinet.
